<b>B.</b>	E-tender cannot be accessed after the due date and time of closing of online e-tender for submission of QR & Techno-Commercial Bid & Price Bid mentioned in the NIT
<b>C</b>	The online tender should be submitted strictly as per the terms & conditions and procedures laid down on the GeM Portal website.
<b>D</b>	All future amendments/corrigendum/addenda/clarifications, if any, shall be uploaded on the GeM portal only and not in the Newspaper. Bidders shall keep themselves updated with all such amendments/corrigendum/addenda/clarifications.

3. Bids of only those Bidders who are meeting the Qualification Requirements will be considered for evaluation and award of the Contract.
4. In the event of the specified date for the submission of bids being declared a holiday for the Client, the hard copies of the “**specified documents**” will be received up to the specified time on the next working day. However, the date

and time for online submission of the bids shall continue to be the date and time specified above or any amendment for the same.

Hard copy(ies) of the “**Specified documents**” received by the Client after the deadline for submission of bids will be considered as late Bids even if the Bidder has uploaded the bid within the stipulated deadline. In such a case, the bids (incl. attachments) of the bidder shall not be opened on GeM portal by the client.
6. At any time prior to the deadline for submission of bid, the client may amend the Tender Document by issuing corrigendum / addenda which shall be notified on GeM portal. Therefore, the bidders are advised to visit the site regularly before deadline for submission of bids.
7. The Terms & Conditions of Industrial All Risk policy uploaded on GeM portal shall replace/supersede the General Terms & Conditions (GTC) including SLA of GeM portal and the contract shall be governed by Terms & Conditions of RFP/Bidding document only.
8. The bids, as well as all correspondence and documents exchanged by the bidders and the Client, shall be in the English language.
